The workshop will discuss these issues, in addition to how to incorporate current and future projects in studies and potential impacts on the budget for the Phase 2 EIR/EIS. Preferably the workshop will occur before the end of the year. As an <u>action</u> item, the consultant team will develop an outline for the workshop for the Board to consider at the October 26, 2015 Board meeting.

The TAC also discussed plans for including the Board in the TAC meetings currently held the month before the regular Board meetings. It was noted that all agencies may not support that due to the time commitment. As an <u>action</u> item the December 14, 2015 TAC meeting will be modified to include the Board.

7. Logistics for October 8, 2015 State Tour

Plans for the October 8, 2015 tour were discussed. It will be very similar to the recent Congressional tour.

8. Final Distribution of Unused SCWA Phase 1 Funds

SCWA staff noted that the total value of unused funds is still being finalized.
