6. Report from the Chair

6.a Subgroup meeting of August 19, August 25, and September 17, 2021

The Board reviewed the August 19, August 25, and September 17 meetings of the subgroup. In keeping with past direction by the Board, a subgroup also known as the technical team has been meeting to track the progress of Phase 1 and Phase 2 projects, funding options, and developing potential workplans for addressing future issues of interest to NBWRA. The future issues are based on the results of the three county meetings that were held in June. The Subgroup met on August 19, August 25, and September 17, 2021.

7. Declaration of a State of Emergency pursuant to AB361 due to COVID-19 to continue remote meetings until the State of Emergency is rescinded or until January 1, 2024, whichever comes first

The Board discussed the rationale for the declaration and noted that their won agencies have been doing the same. On a motion by Vice Chair Ramos, seconded by Director Gorin, the Declaration of a State of Emergency pursuant to AB361 due to COVID-19 to continue remote meetings until the State of Emergency is rescinded or until January 2, 2024, whichever comes first was unanimously approved by a roll call vote.

8. Consultant Progress Reports

The Board reviewed the consultant progress reports for the period July - August 2021.

9. Financial Reports for Fiscal Years Ending June 30, 2021 and June 30, 2021.

The Board reviewed the financial reports for the periods ending June 30, 2021 and June 30, 2022. All expenses are tracking normally.

10. Future Direction and Next Steps for NBWRA

Members of the technical team discussed issues outlined in the presentation focusing on resilience areas that could become part of NBWRA's program of work. These areas include: continuing recycled water projects, potable reuse assessments, coordinated drought contingency planning, and sea level rise adaptation. The discussion also included a request that the technical team meet with the TAC to further refine the proposed projects/concepts and associated funding opportunities and strategy. Based on input from the TAC, the technical team would then come back to the Board with:

- Updated potential projects/concepts for the Board to review
- Better describe tasks to consider, potential costs, and budget
- Refined project profiles that would link projects/concepts with funding opportunities
- Potential MOU modifications, other member agencies, or organizational changes

The Board and TAC members discussed potential projects and expressed interest in further exploring both projects and funding opportunities. Expanding recycled water projects, exploring direct and indirect potable reuse, drought contingency issues, and sea level rise concerns were all discussed. Director Barnacle encouraged the group to be aspirational in terms of developing projects.

Following further discussion, the Board agreed with having the TAC meet with the technical team as described.

11. Phase 1: Status of Reconciliation and Closeout Activities

Jake Spaulding gave an update on the reconciliation and close out activities for Phase 1. He noted that there is approximately \$800,000 remaining that could be used for projects. The final steps for closeout of Phase 1 are underway.

12. Status of Phase 2

Rene Guillen provided an update on the status of the Phase 2. Projects for SVCSD and Petaluma have been incorporated into the Phase 2 program and agreed to by Reclamation. A formal acceptance letter was sent to Kevin Booker on July 29, 2021for the updated Phase 2 Feasibility Study from Reclamation.

13. Items for the Next Agenda

Items for the next Agenda include regular reports, Phase 1 and Phase 2 Status Reports, Water Bond Status, and a report from the TAC meeting.

14. Comments from the Chair, Board, and Member Agencies.

There were no comments from the Chair, Board, and Member Agencies. The Board discussed options for the next meeting and agreed on November 29, 2021, at the regular time of 9:30 a.m. Board members supported continuation of virtual meetings in order to minimize driving and associated impacts. It was acknowledged that there may be conflict with November 29.

Action Requested

Consider recommendations from the TAC regarding NBWRA moving forward.

Summary

The TAC met on October 20 and 21, 2021. Two meetings need to be held since there was not a single date when all members could participate. The content of the meetings was the same although the discussion was specific to the member agencies participating in each meeting.

Attached for the Board's information is a summary of the TAC meetings. Also attached is the PowerPoint presentation that was used as the basis of discussion. The presentation is similar to what has been presented to the Board at the last few meetings.

Recommendation

- 2. Have the TAC elect a Chair and Vice Chair to be responsible for running TAC meetings and reporting to the Board.
- 3. Set up a schedule through 2022 for both the Board and TAC with the TAC meeting before Board meetings.
- 4. The consultant team offer its assistance to the TAC (and ultimately to the Board) in terms of preparing TAC agendas, reports and recommendations for Board consideration.

The majority of the discussion focused on the four resilience areas and the TAC operation. The following summarizes the discussion.

Resilience Area 1, Continued Recycled Water Support

There was discussion regarding how costs and benefits are determined for both Phase 1 and Phase 2. It was determined that a review of the Memorandum of Understanding and the cost sharing would be beneficial for the Board and TAC. This will be included in the November 29, 2021 Board meeting.

Participants expressed support for continuing recycled water projects. Some agencies are only participating in Phase 1, but will continue to support NBWRA's efforts as Associate Members. Potential additional Phase 2 projects including storage reservoirs and infill projects were noted by Napa San.

Resilience Area 2, Potable Reuse Assessments

Previously, potable reuse was not a priority in the North Bay, as the focus was on non-potable reuse (NPR). The development of indirect potable reuse (IPR) regulations (2014 and 2020) and the pending direct potable reuse (DPR) regulations, the drought, political drivers for more diverse, sustainable and local supplies, changing public perception and the threat of ocean discharge reduction/bans have all contributed to a growing interest in potable reuse in the North Bay. Most agencies recognize that IPR would come first and could be followed by DPR pending results of efforts lead by other agencies in California, new regulations, and local public outreach efforts. Some agencies have already initiated potable reuse studies in their service areas and see a benefit of a regional approach to exploring potable reuse. Specifically:

- MMWD has explored potable reuse in their service area and is currently performing an updated DPR assessment. MMWD expressed support for a regional effort to explore opportunities for supply, storage, and public education toward a regional effort. There is some interest in piloting for DPR to engage the public.
- LGVSD expressed support but as a wastewater agency would need to work with water agency partners MMWD and NMWD to further explore opportunities. LGVSD noted that a satellite treatment plant could pull from any part of the purple pipe system with capacity, as long as figure out where to go with the brine.
- Novato San noted that they would participate if there was a drinking water agency leading the charge.
- Petaluma noted that they are going to develop a master plan update for the utility and are seeking council input on a new direction to address discharge compliance, storage, and system expansion constraints.
- Sonoma Water is not interested at this time because they do not have recycled water.
- SVCSD is watching what is happening statewide and locally, but currently they do not have enough recycled water to supply NPR demands and have excess available supply for potable reuse.
- Napa San is interested in DPR and is currently exploring some potential concepts with American Canyon through the Napa Valley Drought Contingency Plan.
- NMWD is currently working with a consultant on options for enhancing local water supply portfolio, including IPR. Sees value in positioning for a regional potable reuse

project would be a benefit; but the process to develop studies and projects should be well defined.

Napa County does not own water or wastewater facilities but are involved with the flow
of water into the County for municipal users. Drought is stressing the amount of water
they can receive from the State Water Project and there is an interest to shore up overall
water supply. The would be a willing partner with an agency and are also interested in
exploring stormwater capture.

Resilience Area 3, Coordinated Drought Contingency Planning

In 2018, North Bay agencies received funding for a Drought Contingency Plan (DCP), but the Sonoma/Marin County agencies wanted to wait for the completion of their Regional Water Supply Resiliency Plan, thus the funding was transferred to the City of Napa. The completion of the Regional Water Supply Resiliency Plan by spring of 2022 could set the stage to take the next steps to do a DCP for Sonoma-Marin County. Completing a DCP has the benefit of providing access to funding ONLY for agencies that have completed DCPs.

- Sonoma Water and NMWD are interested and recognize that the DCP could build off the Regional Water Supply Resiliency Plan.
- There is less interest amongst the wastewater agencies, SCVSD, Napa San and LGVSD, as they do not see this relating to their mission unless there is a direct NPR connection and appropriate partner water agencies.
- Napa San is already participating in a DCP and does not see a benefit in being part of a DCP outside their county.

Resilience Area 4, Sea Level Rise Adaptation

There is an extensive amount of work to address Sea Level Rise (SLR) in Marin, Sonoma and Napa counties, to address high risk structures and opportunities to reduce risk. Since SLR is not a local issue, there could be significant benefits in the development of a North Bay Adaption Plan to identify and prioritize projects that have the greatest regional benefits.

- LGVSD has a high level of interest, as SLR is a big concern for the District. LGVD recognizes the need for regional coordination to avoid redundancies. They are working with Marin County parks and exploring options to protect their wastewater treatment and collection facilities.
- Sonoma Water facilities are low risk to SLR for now, but there could be issues with pipelines to the south. They have submitted a climate adaptation plan to the Board. They would be interested in broader studies on the issue.
- SVCSD has mostly inland facilities, but their reclamation facilities could be impacted by SLR. Sonoma Land Trust and SVCWD have been working together to brainstorm ideas to protect facilities. SVCSD has interest as long as this effort does not overlap with other efforts.
- Novato San is interested but would not serve as a lead agency since their facilities are not heavily impacted by SLR in the near-term.
- Napa County is interested.
- Napa San has a climate change study underway that could result in a regional effort.

• NMWD does not have a high level of interest in this topic but they are interested in what other counties are doing.

TAC Operation Moving Forward

Several members expressed support for the way the TAC operated for Phase 1 and that the group has seemed to have lost focus since that time. Past communication issues were acknowledged, but those can be remedied. The conclusion was that the TAC needs to be active in reviewing issues and bringing recommendations to the Board. Recommendations would include projects, budgets, cost sharing, and MOU modifications.

 - Agency managers and the Program Manager worked to revise the MOU; many meetings were held
- First Amended MOU approved September 2010
 - $_{\circ}~$ Established both the Board of Directors and the Technical Advisory Committee
- First Board Meeting held February 12, 2011 at Novato SD
- First TAC Meeting was a Teleconference held on May 16, 2010 (the TAC was in MOU drafts)
- TAC reviewed and recommended approval:
 - $_{\circ}~$ Evaluated RFPs, Consultant selection, and Consultant scopes of work and costs
 - Annual Budgets
 - Phase 1 EIR/EIS
 - Phase 2 Projects (2015)

- Initially Phase 1 and Phase 2 met separately; combined to be more efficient
- TAC met regularly until Phase 1 was well underway; Board met every other month
- **TAC** met after Board meetings to help plan next Board meeting
- **b** Joint Board and TAC workshops in 2015 and 2016
- **Separate TAC meetings ended in mid-2016**
- Meetings after that were intended to be joint TAC and Board
- **b** Board became solely responsible for Program Direction and Budget Oversight

Summary of NBWRA Survey and County Meetings

- Gathered good feedback and we believe there is an opportunity for NBWRA to provide value to the North Bay beyond recycled water
- North Bay agencies all face common resiliency threats
 - $_{\circ}~$ Water supply/ drought, saline intrusion, sea level rise, changing regulations
- Through recycled water, NBWRA has successfully implemented a program for a more resilient local water supply
- Beyond recycled water, there is no framework for sub-regional resilience planning and implementation in the North Bay

Expanding the focus of NBWRA to a broader resilience planning approach increases funding source opportunities for the identified areas of interest



Resilience Approach – Resilience Arenas

Resilience can be an organizing principle across all these areas of interest

- Based on feedback, the following resilience arenas were identified:
 - **Recycled Water** continue to support ongoing efforts to implement recycled water projects in the region
 - Potable Reuse explore conjunctive use opportunities through the implementation of indirect and direct potable reuse
 - **Coordinated Drought Response Planning** consider development of regional based drought response





Resilience Arena 2 – Potable Reuse Assessments

Proposed Action:

• Conduct preliminary assessments to identify potential purified water use opportunities. These initial assessments will help establish the basis for a future feasibility study if the assessments find viable alternatives.

Funding Opportunities:

The SWRCB offers planning grants ranging from \$75k to \$150k. This could also be developed into a "Phase 3 Program" that would look to develop a Title XVI Feasibility Study with a focus on purified water opportunities.

Timeline:

Given the focus of recent funding opportunities and ongoing drought conditions, the Technical team believes it would be wise to get started on these purified water assessments as soon as practicable to identify viable alternatives and further refine them if needed.

Item No. 6.a Resilience Arena 3 – Coordinated Drought Contingency Planning

Proposed Action:

Consider undertaking the development of a Sonoma/Marin County focused Drought Contingency Plan (DCP). These studies support collaborative planning efforts that use a proactive approach to build long-term resiliency to drought.

Funding Opportunities:

DCPs are funded through Reclamation's WaterSMART Drought Response Program. These opportunities offer a 50/50 cost-share with local stakeholder contribution. Projects (i.e., Mitigation and Response Actions) identified in the DCP effort are eligible for implementation funding.

Timeline:

Studies require interested parties prepare an application. If selected by Reclamation, the studies can take up to 2-years to complete.

ITEM NO. 7 REVIEW OF THE MEMORANDUM OF UNDERSTANDING

Action Requested

None at this time.

Summary

The NBWRA Memorandum of Understanding (MOU) dates back to March 15, 2005. It has been amended four times: September 25, 2008, November 3, 2020, March 25, 2013, and November 17, 2017. The most recent update is the November 17, 2017 Fourth Amended MOU, copy attached. Updates have typically been to add detail for new programs, including Phase 1 and Phase 2. Key elements of the MOU include the following:

Recitals

- Describe the types of projects
- Items specific to Phase 1
- Items specific to Phase 2

Definitions

- Listed alphabetically for convenience
- Defines various items including membership types, Board of Directors, various costs, Phase 1 and Phase 2 EIR/EIS, Technical Advisory Committee

Purpose

- The purpose of NBWRA is to provide recycled water for agricultural, urban, and environmental uses thereby reducing reliance on local and imported surface water and groundwater supplies and reducing the amount of treated effluent released to San Pablo Bay and its tributaries.
- Note: If NBWRA adds some of the Resilience Areas being discussed, the purpose will need to be revised.

Objectives

- NBWRA projects will promote the expanded beneficial use of recycled water in the North Bay Region to:
 - (a) Offset urban and agricultural demands on surface water and groundwater supplies;
 - (b) Enhance local and regional ecosystems;
 - (c) Improve local and regional water supply reliability;
 - (d) Maintain and protect public health and safety;
 - (e) Promote sustainable practices;
 - (f) Give top priority to local needs for recycled water, and
 - (g) Implement recycled water facilities in an economically viable manner.

Phase 1 Cost Sharing and Distribution of Funds Received

- Requires a separate agreement between the administrative agency and the member agencies.
- Joint use costs are shared equally by all Phase 1 and Phase 2 agencies.
- Distribution of funds is based on the project schedule cost as detailed in Exhibit C

Phase 2 Cost Sharing and Distribution of Funds Received

- Similar to Phase 1, but more detail since the EIR/EIS had not been completed
- Feasibility Study costs shared on the basis of Phase 2 project costs
- EIR/EIS costs based on each agency's share of total project costs in the Final EIR/EIS, further described in Exhibit D
- Includes indemnification and hold harmless language
- Distribution of funds is based on project cost schedule for federal funding authorization which is specified at \$75,600,000 as described in Exhibit E
- •Note: this section will need to be revised once there is a Final EIR/EIS and federal funding is received.

Initiation of Membership

- Specific to new members for Phase 2: MMWD, Petaluma, and American Canyon
- Requires an initiation fee of 0.6% of their project costs based on Phase 2 scoping study
- Initiation fees are for Phase 1 agencies to recover a portion of their investment

Termination of Membership

The term of the MOU is five years from the effective date, or through November 15, 2022 Note: The Board will need to consider the term within the next six months as the approval process is lengthy.

374	majority vote. Should no other party be designated to act as Administrative Agency by the
375	effective date of the resignation, the MOU shall terminate and the Administrative Agency

ITEM NO. 8 FUTURE DIRECTION AND NEXT STEPS FOR NBWRA

Action Requested

It is requested that the Board continue the discussion that began with the Report from the Technical Advisory Committee.

Summary

At the last few meetings, the concept of **Resilience** was discussed. Resilience is often defined as being able to adapt well and bounce back quickly in times of stress. In the fields of **engineering** and **construction**, **resilience** is the ability to absorb or avoid damage without suffering complete failure and is an objective of design, maintenance and restoration for buildings and infrastructure, as well as communities. It is not just to be able to recover from threats and stresses, but rather to be able to perform as needed under a variety of conditions – and to respond appropriately to both disturbances and opportunities.

The consultant team prepared the PowerPoint presentation that is included in Item No. 6.a. to assist the Board in evaluating potential issues including Recycled Water, Potable Reuse, Coordinated Drought Response Planning, and Sea Level Rise Adaptation. The presentation includes suggested actions, funding opportunities, and a timeline for each of the issues.

Recommendation

It is recommended that the Board discuss the probable future direction for NBWRA and provide direction for the technical team. It is also recommended that the Chair authorize TAC meetings to better evaluate each agency's interest in the issues that have been identified, discuss with their respective boards and provide recommendations for the NBWRA Board to consider at a future meeting. Action Requested

Declare a State of Emergency due to COVID-19 to allow for the continuation of remote meetings until the State of Emergency is rescinded or until January 1, 2024, whichever comes first.

Summary

Executive Orders from the Governor have allowed public agencies to hold remote meetings and still be incompliance with the Brown Act. Those orders expired September 30, 2021. The legislature passed and the governor has signed AB361 which allows public agencies to continue to hold remote meeting and still comply with the Brown Act. However, in order to continue remote meetings each public agency must declare a state of emergency due to COVID-19. This allows the continuation of remote meetings until the state of emergency is rescinded or until the ability sunsets on January 2, 2024 s specified in the legislation.

At the last meeting, Board members expressed a desire to continue remote meetings in an effort to minimize the carbon footprint of the meetings which have 25-30 people traveling from the three counties to Novato. AB361 will allow for the continuation of remote meetings. There may be additional requirements that have not yet been identified.

Recommendation

It is recommended that the Board Declare a State of Emergency due to COVID-19 to allow for the continuation of remote meetings until the State of Emergency is rescinded or until January 1, 2024, whichever comes first.

The consultant team submitted the updated Phase 2 Feasibility Study to Reclamation for their review on May 10, 2021. The updated document integrated the new SVCSD and Petaluma projects into the existing Phase 2 Program. The new projects were integrated as follows:

- For SVCSD, the 8th Street East Pipeline was combined with the existing Napa Road Pipeline Project to create the new 8th Street East and Napa Road Pipeline Project.
- For the City of Petaluma, both the Maria Pipeline and Adobe Road Pipeline projects were integrated into the existing Agricultural Recycled Water Expansion Project.

On July 29, 2021, Kevin Booker received both a transmittal letter and an approval memorandum for the updated Phase 2 Feasibility Study from Reclamation. The updated Feasibility Study should allow the group to include the new projects in any future Title XVI grant application. We are on hold until a Title XVI funding opportunity presents itself or/if the agencies request an update to the feasibility study.
